

Iron County Hospital District Board Meeting Thursday, March 28, 2019

Meeting was called to order by Acting President Norma Owens at 4:00 pm in the ICMC Conference Room. Board Members present were: Norma Owens, Randy Matthiesen, Bill Thompson, Brian Parker (joining meeting at 5:27 pm) and Eddie Kelley. Members absent were Bob Dunn. Guests included: Joshua Gilmore (CEO), Cindy Sadler (CNO), Dr. Bruce Harrison (Chief of Staff) and Kayla Chamberlain (Finance). Christi Johnson was present to take minutes.

Owens asked if minutes from the February 28, 2019 board meeting had been received and if so, were there any objections, corrections, or additions. Thompson made a motion to approve minutes. Matthiesen seconded.

3 yeas. Motion carried.

Hospital & Board Administration/Operation Matters

a. Financial Report/Payment of Bills

Gilmore reported he has been working closely with Chamberlain and noted she is doing a phenomenal job with the finance team. Chamberlain reviewed the Balance Sheet and stated cash reserves continue to grow. She noted the AR is slightly up but the AP is down to \$93K. The levels of care have been broken out on the income statement to show patient revenue. An income of \$76K was reported for the month of February.

Gilmore requested to pay bills as cash flow allows. Matthiesen made a motion to pay bills and approve financials as requested. Thompson seconded.

b. CEO Report and Board Notifications/Approval Items

Gilmore noted the language for Medicaid is being finalized and ongoing negotiations continue with the USDA and Medicare. An April 10th court date has been set with the USDA and we are awaiting them to finalize plan.

Sadler presented the newly formatted Balanced Scorecard template for Board review along with the QAPI monthly report handout. The Board underwent the annual ICMC Compliance Training via power point presentation. Kelley made a motion to approve QAPI and Compliance Training as presented. Matthiesen seconded.

New Business

Gilmore reported that Dr. Bruce Harrison has been elected Chief of Staff, Dr. Zia Ahmad-Vice Chief of Staff, and Dr. Dana Day-Secretary/Treasurer by a unanimous Medical Staff vote. Kelley made a motion to approve Medical Staff elected officers as presented. Thompson seconded.

3 yeas. Motion carried.

Dr. Dana Day will be replacing Dr. Francisco Garriga at the RHC on April 1st. Day will continue to work in the ICMC ER.

In May Gilmore and Sadler will attend the Rural Health Conference in Atlanta as speakers with DRCHSD.

A discussion was held in regards to changing the meeting date and will be tabled to next month. Owens reported she has a possible candidate to fill the Viburnum Board position.
